- Actual example of a five-page MLA formatted research paper (Click on the PDF links within this ebook) on why “Cyber Bullying Should Be a Crime and the Legal System Should Treat Cyber Bullying Accordingly.” This includes the introductory paragraph with thesis statement, body of paper supporting the thesis statement, concluding paragraph with restating the thesis, and the works cited page. We cite nine different authors (sources) “in text.”

A majority of the resources have been published within the past five years, but we have included a list of some resources that are a little older than five years. These older sources are so helpful that we felt that we should list them. You do not have to cite

information from these older sources, but you can use them to understand and get ideas about cyber bullying.
