"ERISA is a comprehensive statute designed to promote the interests of employees and their beneficiaries in employee benefit plans." *Ingersoll-Rand Co. v. McClendon*, 498 U.S. 133, 137, 111 S. Ct. 478, 482 (1990) (internal quotation marks omitted). To protect participants in employee benefit plans and their beneficiaries, ERISA "establish[es] standards of conduct, responsibility, and obligation for fiduciaries of employee benefit plans." *Pilot Life Ins. Co. v. Dedeaux*, 481 U.S. 41, 44, 107 S. Ct. 1549, 1551 (1987). *Fuller v. Suntrust Banks, Inc.*, (11th Cir. 2014)

ERISA's fiduciary duties are the "highest known to law." *ITPE Pension Fund v. Hall*, 334 F.3d 1011, 1013 (11th Cir. 2003). Under ERISA, a fiduciary must "discharge his duties with respect to a plan solely in the interest of the participants and beneficiaries" and "for the exclusive purpose of: (i) providing benefits to participants and their beneficiaries; and (ii) defraying reasonable expenses of administering the plan." ERISA § 404(a)(1)(A), 29 U.S.C. § 1104(a)(1)(A). Further, a fiduciary must discharge his duties "with the care, skill, prudence, and diligence under the circumstances then prevailing that a prudent man acting in a like capacity and familiar with such matters would use in the conduct of a like character and with like aims." ERISA § 404(a)(1)(B); 29 U.S.C. § 1104(a)(1)(B). We have summarized the duties of loyalty and prudence under 29 U.S.C. § 1104(a)(1)(A)-(B) as follows: "[a] fiduciary must act exclusively for the fund's benefit . . . and must exercise the care of a prudent person." *Brock v. Nellis*, 809 F.2d 753, 754 n.1 (11th Cir. 1987). *Fuller v. Suntrust Banks, Inc.*, *ibid.*
